

Liability Release and Waiver- Electronic/Paper Copy Submission Required

1. In consideration of FC Blazers accepting the Player as a Player for FC Blazers , I hereby for myself and the Player, our heirs, executors, successors, administrators and assigns waive, release, indemnify, and discharge all rights and claims for damages, liabilities, demands and any other actions which I may have now or in the future against FC Blazers, its officers, directors, employees, agents and affiliates, and their respective heirs and legal representatives and those entities' representatives, successors and assigns, including the owner of fields and facilities utilized by FC Blazers (collectively, the "Club"), arising from, resulting from, or relating in any way to, participation in any Club activity, game, tournament, or event, including all claims for personal injuries, property damage, and/or invasion of rights of privacy sustained traveling to or from any activity, game, tournament or event, whether caused or alleged to be caused in whole or in part by the negligence of the Club or otherwise. I also hereby agree to not sue the Club for any matter arising out of, connected with, or relating in any way to participation in a Club activity, game, tournament or event.
2. I acknowledge that Club activities, games and events may be physically demanding and carry the possibility of serious injury, including permanent injury or death. I hereby warrant and represent to the Club that; (a) the Player is physically and emotionally fit and sufficiently trained to be a Club Player; (b) the Player and I knowingly and voluntarily assume all risk and responsibility whatsoever associated with participation in Club activities, games tournaments, and events; (c) the Player and I will comply with all rules and regulations of the Club; and (d) the Player and I have carefully read and fully understand this Liability Release and Waiver and willingly agree to all of the conditions and obligations set forth herein.
3. I understand and agree that my or the Player's failure to abide by all the rules and regulations of the Club or to follow any other instructions given by the Club, may be grounds for the Player's immediate expulsion, and termination of the Player Agreement, without refund of tuition.
4. This Release and Waiver (a) shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts without regard to principles of conflict of laws thereof and (b) is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Release Waiver is held to be invalid or legally unenforceable for any reason, the remainder shall not be affected thereby and shall remain valid and fully enforceable.
